Marie's goal of \$1,000. The book sale is important to the community, because it

led to a member saying they'd like two signs for the upcoming millage campaign. Many compliments on organization of sale. Could we raise prices on young adult

books? Marie suggested this because we could make more if we increase these.

IV. **DIRECTOR'S REPORT**

Director's Report. Discussion of entryway construction. Lots of damage to things throughout the process which is being fixed. One of the issues to be repaired is one of the bike racks donated by the Friends of the Library. Staffing issues continue. Winter Reading Program being organized now. Virtual programs did not have good attendance, so transitioning back to in-person programs. Have saved \$700,000 toward redecoration project. Need to come up with

a strategic plan and start doing some work. STEM kits – state aid increased by \$5,000, using that to create kits that can be checked out.

- A. Friends By-laws. Jacalynn submitted the bylaws with notes to Tim Tomlinson. He said he's working on it, has questions to clarify.
- B. City Tree Lighting. Plan now seems to be to do a drive thru event in front of City Hall. We will be informed about what the city is doing and will determine what kind of involvement will be required from Friends.

- A. All-Ages Winter Reading Program Sponsorship: 6 weeks long beginning on MLK Day, a day of service at the library. Prize at the end and a little something at the beginning too like make and take bookmark kit for kids. Going to be contacting local businesses to donate to a gift basket. Would Friends be willing to sponsor supplies not to exceed \$500. This would include the paper for entry forms, incentives to join and prize for finishing.
