1. Library Director Jackie Harvey. National Friends of Libraries Week is October 15-21, 2023, signed up for digital promotional items and online newsletter from United for Libraries. Friends have not had a Facebook page since 2016. Ashton will look into opening a new Facebook page. This will help promote advocates for the library and 2025 millage. She will also save minutes on the friends computer. Do not allow State and Federal 501c to lapse. Wonderful comments about the book sale. We are prepared if anyone wants to challenge an item at the library. In the last 13 years we have only have one CD challenged that was just moved to another location. Friends can support if there is a challenge. Christmas workshop at the library will be going on again. Have not done since 2019. The library will be closed that day to prepare for it. December 7, 2023, 4pm-8pm. Strategic plan was just completed. Interviewed a lot of key members in the community to find out what they want from the library. The short plan is out on the website for the public. There is a longer one for staff available. \$900,000 saved but we cannot do any of the work we need done unless the city

takes care of things in the building. City Manager proposed with the help of bond writers to bring to the residents a vote on November 7,2023. Bond proposed will be \$20 million over 30 years. They will include the library in a total library renovation. Feds will give grants for brick and mortar. Erica is going to write a grant for us for 2.5 million dollars. Jackie is looking for \$4,000 to purchase a new paperback book for all K-5 children in Roseville Schools, public schools have approx. 4,200 students, paperbacks are approx. \$2.00 each; pay for 2 entertainers at the Christmas Workshop at the Library \$650.
